Introduction

Accreditation is a non-governmental, non-profit, self-regulatory, peer-review process based on rigorous standards. Accreditation of educational programs demonstrates the academic institution's agreement to provide a legitimate and valuable product to the student. The accreditation process allows an external, impartial review of the educational program by experienced professionals in the field.

It is the mission of the Council for the Accreditation of Emergency Management & Homeland Security Education (CAEMHSE) to:

- improve the quality of education in the fields of emergency management and homeland security
- increase professionalism
- foster accountability
- offer to the education community a professional assessment of emergency management and homeland security educational programs of higher education in accordance with accepted standards

The Process

1. CAEMHSE Membership (or) Assessment Application (which will include membership)
2. Self-Assessment/Self-Study
3. Site Visit (Initial & 10-yr)
4. Assessment Report:
 - a. Accreditation
 - b. Conditional Accreditation
 - c. Re-accreditation

Scope

The CAEMHSE accreditation process uses standards developed by the Emergency Management Higher and Homeland Security Educational communities, as developed over many years, and described in articles and documents at <https://training.fema.gov/hiedu/emcompetencies.aspx> and <http://insprs.org/wp-content/uploads/2017/09/Journal-of-Homeland-Security-and-Emergency-Management-Development-of-Competency-Based-Education-Standards-for-Homeland-Security-Academic-Programs.pdf>

These standards are voluntary for degree program accreditation, and are applicable to degree programs that are face-to-face (sometimes referred to as brick and mortar institutions), blended/hybrid, and wholly online.

The CAEMHSE is able to assess and accredit associate's, bachelor's, and master's degree programs for emergency management and for homeland security programs.

The program assessment can be conducted virtually, or with one assessor visiting campus, or with a 3-person team visiting. (Programs pay to reimburse assessor travel.)

Membership Types

Academic Program Membership

An academic institution interested in supporting the mission of the CAEMHSE, or beginning the Assessment and Accreditation process (\$100/yr.)

Accredited Program Membership

An Emergency Management or Homeland Security (or related) program at an academic institution offering associate, bachelor's, master's and/or doctoral academic credit or credentials, accredited by the CAEMHSE (\$500/yr., \$100 per additional program)

Individual Membership

An individual member is defined as any person, from any field, with an interest in emergency management and homeland security credentialing, and who agrees to support the mission of the CAEMHSE (\$25/yr.)

Government and Corporate Membership and Sponsorship

Government or Corporate members shall be companies, corporations, consulting firms, contractors, emergency management departments or offices in government, and other entities which are major sources of employment of emergency management graduates, and which support the mission of the CAEMHSE. (Membership \$100/yr. Contact the CAEMHSE President for sponsorship information.)
